## NOTICE

NOTICE is hereby given that the Seventieth (70<sup>th</sup>) Annual General Meeting (AGM) of the Members of Rallis India Limited will be held at Walchand Hirachand Hall, 4<sup>th</sup> Floor, Indian Merchants' Chamber Building, IMC Marg, Churchgate, Mumbai 400 020, on Monday, 2<sup>nd</sup> July, 2018 at 3.00 p.m.

The Notice of the Meeting and the Explanatory Statement along with the Audited Standalone and Consolidated Financial Statements, Report of the Board of Directors and the Auditors' Report for the Financial Year ended 31<sup>st</sup> March, 2018 has been sent electronically to those Members whose email addresses are registered with the Company/ Depository Participant for communication purposes and the dispatch has been completed on 6<sup>th</sup> June, 2018. For Members who have not registered their email addresses or have requested for hard copies, the Annual Report has been sent at their registered address by Speed Post/ Registered Air Mail/ Courier and the dispatch of the same has been completed on 7<sup>th</sup> June, 2018.

Members are hereby informed that in compliance with the provisions of Section 108 of the Companies Act, 2013, read with Rule 20 of The Companies (Management and Administration) Rules, 2014 as amended from time to time, and Regulation 44 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, Rallis India Limited (Rallis) is providing to the Members the facility to exercise their right to vote at the 70<sup>th</sup> AGM by electronic means and the business may be transacted through the e-voting services (remote e-voting) provided by National Securities Depository Ltd. (NSDL).

The instructions for e-voting are given in the Notice of the AGM. Members are requested to note the following:

- a) The remote e-voting will commence on **Thursday, 28<sup>th</sup> June, 2018 at 9.00 am** and will end on **Sunday, 1<sup>st</sup> July, 2018 at 5.00 pm**. The e-voting module shall be disabled by NSDL for voting thereafter and Members will not be allowed to vote electronically beyond the said date and time.
- b) The voting rights of the shareholders (for voting through remote e-voting or by Poll paper at the Meeting) shall be in proportion to their share of the paid-up equity share capital of the Company as on **25<sup>th</sup> June, 2018 ("Cut-Off Date")**. A person whose name is recorded in the Register of Members or in the Register of Beneficial Owners maintained by the Depositories as on the cut-off date only shall be entitled to avail the facility of remote e-voting as well as voting at the AGM.
- c) Any person who acquires Shares of the Company and become a Member of the Company after the dispatch of the AGM Notice and holds shares as on the cut-off date, i.e. 25<sup>th</sup> June, 2018, may obtain the login Id and password by sending a request at [evoting@nsdl.co.in](mailto:evoting@nsdl.co.in) or may contact on toll free number provided by NSDL:1800-222-990.
- d) Facility of voting through Poll paper shall also be made available at the Meeting. Members attending the Meeting, who have not already cast their vote by remote e-voting shall be able to exercise their right at the Meeting.
- e) Members who have cast their vote by remote e-voting prior to the Meeting may also attend the Meeting, but shall not be entitled to vote again at the AGM.
